*Draft Finding of No Significant Impact (FONSI), pg. 1: "Under Alternative C, no parcels located within or adjacent to an area preliminarily identified as a migration corridor for pronghorn would not be offered for lease. MT Fish, Wildlife and Parks is currently conducting a three-year telemetry study that will identify seasonal ranges and movement corridors. Preliminary data from the first year and a half of the three-year study indicates that pronghorn are traveling between six lease parcels to move between spring/summer range to winter range."
